



## MEMORANDUM OF AGREEMENT

The **Faculty of Agriculture, Ubon Ratchathani University (UBU), Thailand** and the **College of Aquaculture and Fisheries, Can Tho University, Vietnam** agree to enter into this Memorandum of Agreement (MOA) to implement the following collaborative activities *in the fields of aquaculture and fisheries*:

**1. Exchange of teaching and research personnel**

Lecturers and researchers with different and strong specializations from the two parties will be invited to give courses and/or seminars to undergraduate and graduate students and staff, especially to the international educational programs of the parties at appropriate times.

**2. Exchange of students**

Undergraduate and graduate students from each party will be invited to conduct exchange programs such as degree programs, credit transfer, short training courses, seminars, study-tours, thesis research, cultural performances, involving the two parties.

**3. Collaboration in research projects**

The two parties agree to co-operate to develop, apply, and conduct international research projects in issues in aquaculture and fisheries. Teaching staff and researchers from each party will be invited from time to time to conduct joint research with the other party.

**4. International training, workshop, study-tour programs**

The two parties agree to establish international or joint short training-workshops, study-tour programs for local and international trainees (farmers, technicians, company managers, and/or local officers). The specific courses will be identified yearly. Experts and professors from one party will be invited to offer training-workshops organized at the other party. The two parties will provide their own budget in organizing and promoting the study-tours for trainees unless financial aid is available from granting body.

**5. Publication of research results**

The two parties agree to publish joint research results in international journals and books on aquaculture and fisheries.

**6. Organization of symposia and other academic activities**

The two parties agree to organize bilateral joint symposia and join other regional and international symposia in aquaculture and fisheries.

**7. General agreements**

The two parties agree to make their best efforts for specific joint projects and/or programs mentioned above. Detailed programs and projects including activities and budgets will be determined accordingly. This MOA may be modified through discussion by the two parties. This remains in effect from the date of signature for an initial period of five years. Thereafter it will automatically be renewed each year if there is no notice of termination from either party.
