



**MEMORANDUM OF UNDERSTANDING**

**Ubon Ratchathani University, Thailand,**  
**and**  
**Universitas Muhammadiyah Yogyakarta, Indonesia**



**THIS MEMORANDUM OF UNDERSTANDING** is made on.....30 OCT..... 2017

**between**

**UBON RATCHATHANI UNIVERSITY** (hereinafter referred to as "**UBU**"), an institution of higher learning established as a university by Royal Charter in 1990 and having its address at 85 Sathonlamark Road, Warin Chamrap, Ubon Ratchathani 34190, Ubon Ratchathani University, Thailand, of the one part;

and

**UNIVERSITAS MUHAMMADIYAH YOGYAKARTA** (hereinafter referred to as "**UMY**"), a private institution of higher education learning established on March 1981 as part of Muhammadiyah social organization and having its address at Jl. Lingkar Selatan, Tamantirto, kasihan, Special Region of Yogyakarta, INDONESIA; of the second part.

**UBU** and **UMY** shall hereinafter be referred to singularly as "the Party" and jointly as "the Parties".

Both parties recognize the benefits strong international links. To this aim we propose the following agreement:


1. The purpose of this agreement are to develop academic and education collaboration and to promote a joint relationship between the UBU and UMY
2. Both institutions undertake to promote and develop cooperation in the following ways, on the basis of equality and reciprocity:
  - a. Exchange of teaching staff/lecturers
  - b. Exchange of researchers
  - c. Exchange of students
  - d. Exchange of academic information and publications
  - e. Conducting reciprocal lectures and seminars
  - f. Cooperating in research and the publication of its result
  - g. Identifying other mutually agreed opportunities for collaboration
3. To implement these forms for cooperation, representative of our individual institute/faculty will be encouraged to consult with each other and to develop specific plans for collaboration in any or all of the ways outlined in agreement two above.
4. It is understood that the implementation of any of the types of cooperation stated in agreement two above shall depend on our mutual availability of resources and financial support from our respective institutes.
5. This agreement will come into effect on the date when the representatives of both parties sign the agreement and will remain valid for period of five years. The agreement may be ax tented after discussion with representatives of both parties. Such discussion needs to commence not later than six months before the termination of the agreement



6. The agreement may be revised or modified within that period by mutual consent. Similarly, the agreement may be terminated within the period by either party providing six months notice is given to the other
7. The evaluation will be conducted by UBU and UMY after five years implementation of this MOU and changes may be available to those which will adjust with the new collegial institution.
